How do I claim a battery storage credit?

Battery storage technology must have a capacity of at least 3 kilowatt hours. File Form 5695, Residential Energy Credits with your tax return to claim the credit. You must claim the credit for the tax year when the property is installed, not merely purchased.

How does my energy storage system work?

Your energy storage system will charge either from the grid or solar while it is not in use. The amount of stored power will depend on your business's energy usage as well as the size of your energy system. This stored energy will then keep your business powered on during an outage or a PSPS.

Are solar storage systems eligible for a 30 percent credit?

The exact same ITC that provides a 30 percent credit on the cost of your solar system provides that same benefit to storage systems under certain conditions. Due to the Inflation Reduction Act, as of 2023, all residential storage systems over 3 kilowatt-hours (kWh) in size are eligible for the ITC.
