Are energy storage systems safe for commercial buildings?

For all of the technologies listed, as long as appropriate high voltage safety procedures are followed, energy storage systems can be a safe source of power in commercial buildings. If relevant testing standards are not identified, it is possible they are under development by an SDO or by a third-party testing entity that plans to use them to conduct tests until a formal standard has been developed and approved by an SDO.

Who can install energy storage at a facility?

This could include building energy managers, facility managers, and property managers in a variety of sectors. A variety of incentives, metering capabilities, and financing options exist for installing energy storage at a facility, all of which can influence the financial feasibility of a storage project.

Do energy storage systems need a CSR?

Until existing model codes and standards are updated or new ones developed and then adopted, one seeking to deploy energy storage technologies or needing to verify an installation's safety may be challenged in applying current CSRs to an energy storage system (ESS).

What are the new energy standards for commercial buildings in Colorado?

For example, in August 2023, Colorado's Air Quality Control Commission³ established new energy performance standards for buildings 50,000 square feet and larger to reduce energy use and greenhouse gas pollution. Additionally, the overall energy demand for heating and cooling in commercial buildings is expected to increase in the coming years.

Where can energy storage be procured?

Energy storage can be procured directly from "upstream" technology providers, or from "downstream" integration and service companies (FIGURE 2) Error! Reference source not found.. Upstream companies provide the storage technology, power conversion system, thermal management system, and associated software.

The Federal Energy Management Program (FEMP) provides a customizable template for federal government agencies seeking to procure lithium-ion battery energy storage systems (BESS). Agencies are encouraged to add, remove, edit, and/or change any of the template language to fit the needs and requirements of the agency.

The Energy Code is modified every three years, containing energy and water efficiency requirements for newly constructed buildings and modifications to existing buildings. The 2022 update provides crucial steps in California's progress towards achieving 100 percent carbon neutrality by 2045.

As a low carbon alternative, Battery Energy Storage System (BESS) has been viewed as a viable option to replace traditional diesel-fuelled construction site equipment.
