Why is energy storage important?

Energy storage has a critical role in stabilising and integrating the renewables power generation, in our view. Can a power plant be converted to energy storage?

Which countries invest in battery energy storage in 2022?

Global investment in battery energy storage exceeded USD20 billion in 2022, predominantly in grid-scale deployment, which represented more than 65% of total spending in 2022.
