How big is the energy storage industry?

Energy storage systems (ESS) in the U.S. was 27.57 GW in 2022 and is expected to reach 67.01 GW by 2030. The market is estimated to grow at a CAGR of 12.4% over the forecast period. The size of the energy storage industry in the U.S. will be driven by rising electrical applications and the adoption of rigorous energy efficiency standards.

The U.S. held industry share of over 13% of the global energy storage systems market in 2022. Regulatory bodies have been crucial in driving investments in the energy and electric infrastructure and have continued to invest in the development, demonstration, and research of energy storage technologies.

How is energy storage industry segmented?

The report covers US Energy Storage Companies and it is segmented by Technology (Batteries and Other Energy Storage System Technologies), Phase (Single Phase and Three Phase), and End-User (Residential and Commercial & Industrial).

What is the growth rate of industrial energy storage?

Will energy storage grow in 2023?

Global energy storage's record additions in 2023 will be followed by a 27% compound annual growth rate to 2030, with annual additions reaching 110GW/372GWh, or 2.6 times expected 2023 gigawatt installations. Targets and subsidies are translating into project development and power market reforms that favor energy storage.
