Does industry need energy storage standards?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].

Does Italy have a battery storage market?

This report is part of a series that analyses the battery storage market in select European countries. Italy has both a rapidly growing utility-scale market as well as a flourishing customer-sited battery storage market. Customer-sited storage adoption has been mainly driven by a combination of high electricity prices and generous tax incentives.

Why are electricity prices so high in Italy?

Italy's high electricity market prices are largely driven by its heavy reliance on fossil gas for power generation. In Italy, the government and the Italian TSO (Terna) have developed several electricity market products where storage projects are able to compete and provide services to the power system.

Are energy storage codes & standards needed?

Discussions with industry professionals indicate a significant need for standards..." [1,p. 30]. Under this strategic driver, a portion of DOE-funded energy storage research and development (R&D) is directed to actively work with industry to fill energy storage Codes & Standards (C&S) gaps.

How is Bess used in Italy?

How BESS are used Currently, the main possible sources of revenues for BESS in Italy are the following: specific auctions and the capacity market (BESS facilities participated in the 2022, 2023 and 2024 capacity market auctions).

The results of the survey show that 89% of the surveyed installers in Italy offer energy storage to their customers, compared to 64% from last year's survey. A further 10% are planning to include storage solutions in their portfolio by the end of 2022. This development indicates a growing market for storage systems.

The Birth of a Super Plan. The European Commission announced last Thursday the approval of Italy's EUR17.7 billion plan to aid the construction of energy storage facilities exceeding 9 GW/71 GWh. This plan,

slated to continue until the end of 2033, will provide annual payments to electricity storage developers to cover investment and operational costs.

Therefore, battery energy storage systems (BESS) are needed in Italy. The Italian market for BESS is growing rapidly and currently amounts to 2.3 GW but it almost exclusively consists of residential scale systems, associated with small scale solar plants, having an average capacity of less than 20 kWh.
